(ISIN: LU1991437788) Ecofin Sustainable Listed Infrastructure Fund (the 'Fund') is a Sub-Fund of Ecofin SICAV (the 'Company'). Lemanik Asset Management S.A. is the Management Company (the 'Management Company') to the Fund.

Objectives and Investment Policy

- The Fund's investment objective is to achieve a high, secure dividend yield on its portfolio and to realise long-term growth in the capital value of its net assets for the benefit of investors, while taking care to preserve capital.
- The Fund is active and managed without any reference to a benchmark. The Investment Manager has discretion over the composition of its portfolio subject to this objective and investment policy.
- The Fund will invest primarily in the equity and equity-related securities of economic infrastructure companies in developed countries. For the purposes of investment, economic infrastructure companies are those that own and operate assets which are essential to the functioning of developed economies and to economic development and growth, notably transportation-related assets such as roads, railways, ports and airports, and utilities. Utilities, which will comprise a substantial proportion of the Fund's assets, are those involved in the generation, transmission and distribution of electricity including the production of electricity from renewable sources; the transport, storage and distribution of gas; the abstraction, treatment and supply of water and the treatment of waste water; and the provision of environmental services such as recycling and waste management.
- The Fund may invest up to 20% of its total assets in cash, cash-equivalents, and high-quality, short-term debt securities and money market instruments for (i) temporary defensive purposes in response to adverse market, economic or political conditions, and (ii) to retain flexibility in meeting redemptions, paying expenses and identifying and assessing investment opportunities.
- The Fund's net assets will be diversified with respect to geography and sub-sectors of the global infrastructure universe. Although the Fund's net assets will be comprised principally of investments in companies listed on recognised stock exchanges in the United Kingdom, Continental Europe, the United States, Canada and other OECD countries, the Sub-Investment Manager may invest up to 10% of the Fund's net assets, at the time of acquisition, in the securities of companies quoted on recognised stock exchanges in non-OECD countries. The total of the Fund's investments in the United States may amount to 60% of its net assets; the limit for all other countries is 40% of the Fund's net assets although it is highly unlikely that this limit will be reached.
- The Fund's Sub-Investment Manager believes that companies with a thorough understanding of, and strategy around, environmental, social and governance (ESG) issues are more capable of mitigating risks and enhancing their performance over the long-term. Knowledge of ESG factors and risks and active ownership are, therefore, integral to the Sub-Investment Manager's investment philosophy and process.
- The Fund will invest to a considerable extent in securities which are not denominated or quoted in EUR, the Fund's base currency, and therefore movements in exchange rates will have an effect, favorable or unfavorable, on the value of the Fund and on the return on an investment in the Fund's shares. Investment instruments which are not denominated in EUR might be hedged against exchange rate risks.
- The Fund may borrow cash provided that such borrowing is on a temporary basis and represent a maximum of 10% of its net assets.
- The Fund may use derivatives only for efficient portfolio management purposes.
- Sale of shares in the Fund can be made on a daily basis.
- Recommendation: the Fund may not be appropriate for investors who plan to withdraw their money within five years.

In addition to the risk captured by the indicator, the overall Fund value may be considerably affected by:

- **Currency risk:** Variations in the exchange rates between the currencies of the Fund's underlying investments and the currency of the Share Class may adversely affect the Fund's performance.
- **Equity/market risk:** The value of investments are affected by daily stock market movements which may be in response to the activities of an individual company or in response to general market and/or economic conditions, including the possibility of

sudden or prolonged market declines.

- **Interest rate risk:** A rise in interest rates may cause a decline in the value of the Fund's investments.
- **ESG risk:** Securities of companies with ESG practices may shift into and out of favour depending on market and economic conditions, and the Fund's performance may at times be better or worse than the performance of funds that do not use ESG or sustainability criteria.
- **Concentration and liquidity risk:** The Fund will be invested primarily in the equities of economic infrastructure companies in developed countries, and its performance may be more volatile than if it were broadly diversified over industries and sectors. The Fund may invest in small and mid-capitalisation companies which may be subject to liquidity risk, adversely impacting the Fund's ability to sell securities quickly. Volatility of energy commodity prices can also significantly affect infrastructure companies.
- **Operational risk:** The Fund may experience material losses as a result of human error, system and/or process failures, inadequate procedures or controls.
- **Sub-Investment Manager risk:** The value of your investment may vary with the effectiveness of the Sub-Investment Manager's research, analysis and allocation among portfolio securities. If the strategies employed do not produce the expected results, the value of your investment could be diminished and the Fund could underperform other Funds with similar objectives.

Charges

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distribution. These charges reduce the potential growth of your investment. The ongoing charges figure for the respective share class is capped at 2% of the average net asset value ("Capped Figure"). Any ongoing charges in excess of the Capped Figure will be borne by the Investment Manager and will not be charged to the Fund. The ongoing charges figure may vary from year to year. It is possible that the actual ongoing charges figure is lower than the Capped Figure.

The entry and exit charges shown are maximum figures. In some cases you might pay less. Please refer to your financial advisor or the distributor for the actual charges.

As the share class has not had a full year of performance, the ongoing charges figure is an estimated figure.

This figure may vary from year to year. It excludes:

- Performance fees.
- Portfolio transaction costs, except in the case of an entry/exit charge paid by the Fund when buying or selling units in another Fund.
